Noxious Weed Ordinance— Noxious weeds & grasses must be cut by May 20th, June 20th, July 20th & August 20th. Failure to do so will cause the Village of Kaleva to take care of it at owner's expense. If you fail to pay, it will be added to your Village property taxes. Also, violators can receive a civil infraction with a fine up to \$500.

Curfew Ordinance - It shall be unlawful for any person under the age of 16 years to be or remain in or upon the streets or public between the hours 10 p.m.—6:00 a.m. and Friday and Saturday between the hours of 11 p.m. and 6:00 a.m.

Noise Ordinance—Kaleva Ordinance #18 Sec 4 "The keeping of any domestic animals which by causing frequent or long continued noise disturbs the comfort or repose of any person shall be prohibited."

Blight Ordinance— Kaleva Ordinance #9 Sec. 4 "...unlawful for any person to store, or to permit the storage or accumulation of trash, rubbish, junk, junk automobiles or abandoned vehicles on any private property in the village except within a completely enclosed building."
